All entries must be received by 2 p.m., on March 21, 2012. KCGA accepts entries for this competition by mail or delivery. To enter, complete the official entry form and include the \$250 entry fee made payable to Kansas City Golf Association.

### **Rules of Golf & Conditions of Competition**

Play will be governed by the Rules of Golf as established by the USGA. Conditions of the Competition will be governed by the KCGA Local Rules and Conditions of Competition as established by the KCGA. Questions shall be settled by the KCGA Rules & Competitions Committee, whose decision shall be final.
