- 1. True or False:
  - a. A player must take penalty relief for a ball in penalty area that is a no play zone.
  - b. There is no free relief for an embedded ball in a penalty area.
  - c. If a lake is not marked by the committee, it is treated as a yellow penalty area.
  - d. A player may not stand in a penalty area to make a stroke after taking relief from that penalty area.
- 2. In stroke play, Baile's ball is in a penalty area. She grounds her club at address, which moves a leaf that was covering her ball, but her ball does not move. What is the ruling?
  - a. No penalty, this is allowed.
  - b. No penalty, but the leaf must be replaced.
  - c. Baile gets 2 penalty strokes.
  - d. Baile gets 4 penalty strokes.
- 3. In stroke play, Taylor's tee shot is at rest in a red penalty area. She correctly determines her 2-club length relief area, a part of which is on the putting green. She drops a ball that strikes in the relief area on the putting green and rolls onto the fringe in the measured relief area. She plays the ball from there and holes the shot. What is her score for the hole?

- 4. In stroke play, Todd's tee shot is at rest in a penalty area that is a no play zone. He plays a stroke from the no play zone that stays in the no play zone. He then plays another stroke that comes to rest on the putting green and holes that putt. What is Todd's score for the hole?

  - d. Disqualification.
- 5. In individual stroke play, Doug's ball is at rest in a red penalty area and elects to take lateral relief. He drops the ball in the right way, but it comes to rest outside the relief area. He correctly lifts the ball to re drop it but notices a branch overhanging his line of play, so he changes his mind and drops correctly using the back-on-a-line option. Which of the following is correct?
  - a. His ball is in play, with the one stroke penalty for the relief area.
